

## PUBLIC NOTICE

**Subject: All bulk generators to manage their wet waste as per provisions of SWM Rules, 2016.**

In continuation of the above referred notification dated 21.08.2018 published in \_\_\_\_\_ newspaper and in line with the provisions of Solid Waste Management Rules (SWM) 2016 notified by the Government of India on 08.04.2016, it is mandatory for the Bulk Waste Generators (BWG) to carry out certain waste management functions by themselves for management of their municipal waste. .

2. As per these SWM Rules, the Bulk waste generators generating more than 50 kg of waste per day in total from the identified premises/property/establishment need to implement the provisions of the SWM Rules 2016 not later than 60 days( by 22.10.2018) from the date of publication of BWG notice, which includes
  - i. Source segregation of waste into 3 (three) categories/streams (Biodegradable, Non-biodegradable and Domestic hazardous waste);
  - ii. Arrange the storage within premises for Dry waste (including Domestic hazardous waste) for door to door collection and Recycling
  - iii. In-premises processing and treatment of biodegradable (or wet) waste
3. The Biodegradable (or wet) waste generated by Bulk waste Generator, needs to be composted using either on-site compost plant or via agency who will treat on behalf of the bulk generator of the waste.
4. All RWAs, Market Association Members, Hotels and Restaurants etc as defined will be classified as Bulk Generators **unless they submit within the notice period, a self- declaration (available on MCG website) of generating less than 50 kg of waste per day from their premises.** Such self-declaration will be subject to verification and penal costs (up to Rs. 25,000/-) would be leived if found untrue.
5. For Bulk waste generators with onsite compost facilities, following support will be provided:-
  - i. All bulk generators who are managing their wet and dry waste will be exempted from user fee charges of Door to door collection



- ii. MCG shall buy back the compost @ 5 /kg (Rs. Five per K.G.) from residential units only.
  - iii. MCG shall make arrangement for collection of the rejects through authorised waste collector agency only from residential units.
7. All Bulk Waste Generators are required to fill the required details online on MCG website as listed in annexure A (please choose the relevant Form).
  8. The provisions of this notice shall come in force with immediate effect.

**PUBLIC NOTICE**

**Under Clause 4 of Solid Waste Management Rules, 2016**

It has been brought to notice that various bulk generators (generating more than 100 kg waste daily) are not segregating waste at their level and handling over un-segregated waste to authorized waste collector of MCG.

As per SWM Rules, 2016, all bulk waste generators shall, within one year from the date of notification of these rules and in partnership with the local body ensure segregation of waste at source as prescribed in these rules and facilitate collection of segregated waste in separate streams.

As per clause 4 of SWM Rules, 2016, if any bulk generators is found handling over the un-segregated garbage to the authorized waste collector, user charges at twice the rates notified vide order no. MCG/2017/50091 dated 05.09.2017 will be imposed on bulk waste generators.

It is intimated that those waste generators including Resident Welfare Associations handling waste generated in their area who are performing work of source segregation, decentralized in site composting and sending the dry (non-biodegradable) waste to designated secondary collection point, will be exempted from paying user charges fixed by MCG vide Notification No. MCG/2017/50091 dated 05.09.2017.

This order shall come into force with immediate effect.
