Subject: - Notice regarding Solid Waste Management Rules 2016 compliance and COVID-19 waste management.

- 1. Whereas as per the public notice issued by MCG for compliance of solid waste Management Rules 2016, it is mandatory for waste generator to segregate waste into 3 streams (Wet, Dry & Domestic Hazardous/Biomedical) (details of waste category is attached at Annexure-A) and that there should be no mixing of wet, dry & domestic hazardous waste at any time. The processing of wet waste (Bio-degradable) is to be done in the premises by Waste Generators (generating more than 50KG waste in total, specified under Bulk waste generators) and such BWG will make arrangement for setting up of composting unit at their own level. Waste generators shall not throw, burn or bury the solid waste generated by them.
- 2. Whereas Municipal Corporation, Gurugram has notified and published various Public Notices for implementing and achieving the targets mentioned in SWM Rules, 2016 in time bound manner from time to time viz., (on 20.08.2018, 26.09.2018 and 25.10.2018). In continuation of Bulk waste generator compliances of wet waste management within the premises, it is further directed to all waste generators to ensure waste segregation into 3 streams.
- 3. Also considering the present epidemic COVID-19 situation it is also directed that Domestic hazardous waste including sanitary waste, used PPE kits, mask, gloves etc. used by sanitation staff or residents to be stored separately and handed over separately to waste collector in yellow bags. Yellow bags are





available on all waste collection vehicles of concessionaire. This waste should never be mixed with wet waste or dry waste at any cost.

- 4. For management of waste from Home quarantine, the persons taking care of home-care/quarantine suspected COVID-19 persons need to follow the below mentioned steps to ensure safe handling and disposal of waste:
 - i. Non-contaminated General solid waste (household waste) generated from home quarantine should be handed-over to authorized municipal solid waste collector as per the prevailing general SWM Rules 2016 Noncontaminated General waste should not be stored in yellow bags.
 - ii. General waste may comprise of the waste generated from kitchen, packaging material for groceries, food material, waste papers, waste plastics, floor cleaning dust, etc. generated and handled by patient caretakers or the suspected quarantined persons
 - iii. Biomedical waste if any generated from home quarantine should be collected separately in yellow bags (suitable for biomedical waste collection) provided by MCG on all separately deployed collection vehicles. These bags can be placed in separate and dedicated dust-bins of appropriate size.
 - iv. Biomedical waste at Home-care/ Quarantine may comprise of used syringes, date expired or discarded medicines, used masks/gloves and in case of patients with other chronic diseases may also include drain bags, urine bags, body fluid or blood soaked tissues/cotton, empty ampules etc.
 - v. General waste such as like fruit/vegetable peel offs, left-over food, empty juice bottles or tetra packs, empty water bottles, packaging material, discarded papers, carton boxes, and any other items which were not contaminated by secretions or body fluids of COVID-19 positive person should be disposed-off as general solid waste. This waste shall not be collected in yellow bag
 - vi. General waste contaminated with blood or body fluids from persons infected with COVID-19 shall be segregated in yellow bag along with masks and gloves used by them



- 5. Further due to increase in rise of daily COVID-19 patients it is directed to RWAs to deploy a separate team of workers who shall be engaged in door step waste collection from COVID home quarantine. All biomedical waste to be collected in yellow bags by RWAs/society. These yellow bags will be available and provided by MCG on separate COVID-19 waste collection van.
- 6. The person taking care of home quarantine patients shall handover the waste in yellow bags to collection staff at door step. The collection staff shall spray the disinfectant (1% hypochlorite solution) on the bin/bag used for yellow bag before lifting from door step.
- 7. As a matter of caution, the bags containing general waste may be sprayed with disinfectant solution (1% sodium hypochlorite solution) prior to handover to authorised waste collector;
- 8. Separate closed & secure storage area for COVID home quarantines waste to be Identify. Biomedical waste collected from home quarantine can also be lifted directly from house into separate COVID waste collection van without separate storage.
- 9. Collection staff shall be provided with adequate Personnel Protective Equipment such as three layer masks, splash proof aprons/gowns, heavy-duty gloves, gum boots and safety goggles in addition to area for cleaning and washing hands. Reusable PPE are preferred over daily disposable PPE.
- 10. These PPEs are required to be worn all the time while collecting of waste from quarantine homes to waste deposition point or vehicle.
- 11. Use dedicated carts / trolleys / vehicles for transport of biomedical/homequarantine patient waste. Ensure sanitization of vehicles with 1% hypochlorite after each trip
- 12. Persons taking care of home Quarantine patient can call area wise supervisor for scheduled collection of biomedical waste as and when it gets generated or in case waste is not picked up. Copy of collection schedule is attached at **Annexure B**.
- 13. Used PPE kits, masks and gloves generated from home quarantine or other households or sanitation/maintenance staff should be kept in separate paper bag

for a minimum of 72hours prior to disposal of the same. These also to be disposed in separate yellow bags either on general MSW collection van or in separate COVID-19 collection van. It is advisable to cut the masks prior to disposal to prevent reuse.

- 14. RWA/society association shall ensure regular sanitization of workers, storage area and collection equipment's/bins/trolley/lifts involved in handling and collection of biomedical waste;
- 15. RWAs should develop SOPs for Residents (for 3way waste segregation), for home quarantine patients and waste collection staff (separate for home-quarantine and others) for 100% compliance of order.
- 16. Biomedical waste generated from Home-care/quarantine would be treated as 'domestic hazardous waste' as defined under Solid Waste Management Rules, 2016, and shall be disposed as per provisions under Biomedical Waste Management Rules, 2016 and these guidelines. Biomedical or contaminated Waste collected from home-quarantines shall only be handed over to authorized waste collector by MCG.
- 17. General waste **not having contamination** should be disposed as solid waste as per SWM Rules, 2016 **only to authorized waste collector and user fees for same to be paid to authorize waste collector only**. Bulk waste generator shall ensure wet waste composting within premises and handover only biomedical, domestic hazardous and dry waste to waste collector.
- 18. Incase society is doing composting of wet waste, which is considered appx. 50% of total waste generated and handling over Dry waste and domestic hazardous waste/biomedical waste to authorized waste collector, then only 50% of notified user fees will be paid to authorized waste collector. Also their waste should also be not more than 50% of total waste generated.
- 19. In case of society doing composting and taking care of dry waste on their own and handling only rejects from composting & domestic hazardous waste (which is appx. 20% of total waste), then only 20% of notified user fees to be paid to authorized waste collector. Also their waste should also be not more than 20% of total waste generated.



- 20. Incase RWA/Society is doing onsite composting and handing over dry waste, biomedical/domestic hazardous waste & inerts to transfer station of authorized waste collector, then user charges will be waved off for waste collection.
- 21. All waste (both from COVID-19 quarantine house and non-quarantine houses) floor wise will be collected by RWA/society separately and stored within premises or deposited directly into the collection vehicles. All above mentioned precautions to be taken care for handling home quarantine waste. No secondary sorting or waste from COVID-19 Home quarantine waste to be done at any cost.
- 22. Create awareness among residents regarding segregation of municipal solid waste and biomedical waste (as part of Domestic Hazardous Waste) generated from non-homes-quarantine and homes-quarantine. Copy of advisory issued by MCG is attached at Annexure-C.

Solid Waste Management Rules, 2016.

Duties of waste generators. – Every waste generator shall segregate and store the waste generated by them in three separate streams namely biodegradable, non-biodegradable and domestic hazardous wastes in suitable bins and handover segregated wastes to authorised waste pickers or waste collectors as per the direction or notification by the local authorities from time to time
